

# **War and Strikes Risks**

Rates & premium – revised 21 November 2018

The availability of cover against War and Strikes risks is determined by reference to the Risk Level shown in the JCC Cargo Watch List, at http://watch.exclusive-analysis.com/jccwatchlist.html

Unless inclusive rates or in-full premiums are shown in the schedule, the minimum scale rate for war and strikes risks cover will apply to shipments to or from locations covered by NMU cargo policies, **except that**:

1. Where covered, shipments to or from locations for which the Risk Level is "Elevated" or "High" may be subject to a surcharge rate<sup>1</sup> typically not exceeding 0.10% and 0.15% respectively.
